Eligibility: Exhibited items must be original work created by the artist, private businesses such Pampered Chef, Mary Kay, Avon, Lularoe, etc., special interests group fundraisers such as raffles & information booths. No bake sales please. The Jury Committee reserves the right to call for the removal of any inappropriate items.

Applicants must submit five photos of their work: one of work in progress (artists & crafters), one of booth set-up, and three of your media. Please label photos with your name, media, and phoned number. The jury committee will judge entries based on originality, quality of workmanship and media appropriateness. Do not send product samples, flyers or printed brochures. Photos will be returned at registration.

Artists will be notified within 30 days of application being received. Please send a self-addressed envelope if you do not have an email address. All fees and photos will be returned in the event on non-acceptance.

All sites are 12x12. Fee for each site is \$50.00 by May 1, 2019, \$65.00 after May 1, 2019. All exhibitors are required to register at the registration booth upon arrival to the park. You will receive your assigned site number at this time. No exchanging or selling of spaces is allowed. **NO EARLY DISMANTLING, NO ROLLOVERS OR REFUNDS.**

Set-up will be on Saturday 7:00 – 9:30 a.m.

No vehicles or trailers allowed in the park. **NO STAKING WILL BE ALLOWED PER THE CITY OF TAWAS, PLEASE BRING THE PROPER WEIGHTS TO HELP WITH SECURING TENTS.**

Some artists carry their own liability insurance. If you don't have insurance, please know that all exhibits are displayed at the exhibitors' own risk. The City of Tawas City, nor the Tawas Braves Booster Club assumes any responsibility for any injury or loss for any reason to the exhibitor, their assistants, or their property.

No alcoholic beverages are allowed, and spaces must be kept and left clean. All Exhibitors must park across the street at the courthouse during the show hours.
